1	Secretary General shall display the Election Schedule on office of SWCCI, website and submitted to the Regulator (DGTO).	Monday, July 15, 2024
2	The secretary general shall display the provisional list of all members eligible to vote. The list shall be displayed at the SWCCI office and website.	Thursday, July 18, 2024
3	The members who have any objection to the entries in the list of voters shall send their objections in writing to the secretary general within seven days.	Wednesday, July 24, 2024
4	The secretary general shall intimate action on the objections or changes sent by members within five days from the objection date.	Monday, July 29, 2024
5	Any person aggrieved by the decision of the Secretary General may make a representation, within 2 days, to the election commission.	Wednesday, July 31, 2024
6	The Election Commission will decide within 3 days on the cases referred to them.	Saturday, August 3, 2024
7	Any person aggrieved by the decision of the commission may appeal within 3 days, to the Regulator (DGTO) who shall decide the case within 10 days and his decision in this regard shall be final.	Saturday, August 17, 2024

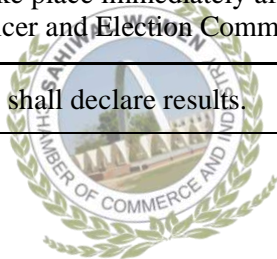

8	The final voters list shall be displayed at the SWCCI office and displayed at the website and submitted to the DGTO.	Wednesday, August 21, 2024
9	Any person who is eligible to contest the election for the vacant post, shall send his nomination duly proposed and seconded by a duly registered voter and signed by the candidate to the Secretary General on the Nomination Form prescribed by the Election Commission.	Monday, August 26, 2024
10	The nomination papers shall be scrutinized by the election commission and list of candidates shall be displayed of the last date of receipt of nomination papers.	Wednesday, August 28, 2024
11	Secretary General shall provide a copy of the final list of voters to each contesting candidate.	Friday, August 30, 2024
12	The objections, if any, to the nomination of the candidates can be filed to the election commission within 24 hours of issuance of the list of candidates,	Monday, September 2, 2024
13	The Election Commission will decide 2 days on the objection to the nomination of the candidates which shall be decided by the Election Commission.	Wednesday, September 4, 2024
14	Any candidate aggrieved by the decision of the Election Commission within stipulated time may file an appeal to the Regulator.	Thursday, September 5, 2024
15	The Regulator who shall decide within 7 days and his decision in this regard shall be final.	Thursday, September 12, 2024
16	Secretary General will receive the withdrawal forms by the candidate who wants to withdraw from the election.	Saturday, September 14, 2024
17	The Election Commission will issue final list of candidates.	Monday, September 16, 2024
18	The polling shall be held at SWCCI office or any suitable and designated place for the members from 9am to 5pm.	Tuesday, September 24, 2024
19	Counting of votes shall take place immediately after the polling hours under the supervision of polling officer and Election Commission at the polling site.	Tuesday, September 24, 2024
20	The Election Commission shall declare results.	Wednesday, September 25, 2024

22	The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed at the SWCCI office.	Saturday, September 28, 2024
25	The polling shall be held for Office Bearer at SWCCI office or any suitable and designated place from 10am to 1pm.	Monday, September 30, 2024
26	The final result of the election of members of Executive Committee and Office Bearers shall be officially announced at the annual general meeting of the SWCCI, called for this purpose but not later than 30th September of the year 2024.	Monday, September 30, 2024

IMPORTANT TO NOTE

- 1) For the purpose of this schedule "Day" means working hours of the Chamber on that day unless otherwise stated.
- 2) If any day on which act scheduled to be performed under the election schedule falls on a holiday, such act shall be performed on the day next following the holiday(s)
- 3) If for any reason any candidate does not receive any of the communications of the Secretary General in connection of the election, the election proceedings shall not be invalidated on that reason.
- 4) Polling hours will be from 9:00 A.M. to 5:00 P.M. with break for lunch and prayer from 1:00 P.M. to 2:00 P.M. (Time can be extended at the discretion of Election Commission)
