7	Any person aggrieved by the decision of the Secretary General may make a representation, within 2 days, to the election commission.	Saturday, 1 August 2026
8	The Election Commission will decide the representation	Monday, 3 August 2026
9	Any person aggrieved by the decision of the commission may appeal within 3 days, to the Regulator who shall decide the case within 10 days and his decision in this regard shall be final.	Monday, 17 August 2026
10	The final voters list shall be displayed at the SWCCI office and displayed at the website and submitted to the DGTO.	Friday, 21 August 2026

11	Any person who is eligible to contest the election for the vacant post, shall send his nomination duly proposed and seconded by a duly registered voter and signed by the candidate to the Secretary General on the Nomination Form prescribed by the Election Commission.	Tuesday, 25 August 2026
12	The nomination papers shall be scrutinized by the election commission and list of candidates shall be displayed of the last date of receipt of nomination papers.	Wednesday, 26 August 2026
13	Secretary General shall provide a copy of the final list of voters to each contesting candidate.	Thursday, 27 August 2026
14	The objections, if any, to the nomination of the candidates can be filed to the election commission within 24 hours of issuance of the list of candidates,	Friday, 28 August 2026
15	The Election Commission will decide objection to the nomination of the candidates which shall be decided by the Election Commission.	Monday, 31 August 2026
16	Any candidate aggrieved by the decision of the Election Commission within stipulated time may file an appeal to the Regulator.	Wednesday, 2 September 2026
17	The Regulator who shall decide within 7 days and his decision in this regard shall be final.	Thursday, 10 September 2026
18	Secretary General will receive the withdrawal forms by the candidate who wants to withdraw from the election.	Saturday, 12 September 2026
19	The Election Commission will issue final list of candidates.	Wednesday, 16 September 2026
20	The polling shall be held at SWCCI office or any suitable and designated place for the members from 9am to 5pm.	Monday, 21 September 2026
21	Counting of votes shall take place immediately after the polling hours under the supervision of polling officer and Election Commission at the polling site.	Monday, 21 September 2026
22	The Election Commission shall declare results.	Monday, 21 September 2026
23	Any person elected as a member of the Executive Committee, shall send his nomination for Election Commission Office Bearer duly proposed and seconded by an elected Executive Committee member and signed by the candidate to the Election Commission.	Wednesday, 23 September 2026

24	The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed at the SWCCI office.	Thursday, 24 September 2026
25	The polling shall be held for Office Bearer at SWCCI office or any suitable and designated place from 10am to 1pm.	Saturday, 26 September 2026
26	The final result of the election of members of Executive Committee and Office Bearers shall be officially announced at the annual general meeting of the SWCCI, called for this purpose but not later than 30th September of the year 2023.	Wednesday, 30 September 2026

IMPORTANT TO NOTE

- 1) For the purpose of this schedule "Day" means working hours of the Chamber on that day unless otherwise stated.
- 2) If any day on which act scheduled to be performed under the election schedule falls on a holiday, such act shall be performed on the day next following the holiday(s)
- 3) If for any reason any candidate does not receive any of the communications of the Secretary General in connection of the election, the election proceedings shall not be invalidated on that reason.
- 4) Polling hours will be from 9:00 A.M. to 5:00 P.M. with break for lunch and prayer from 1:00 P.M. to 2:00 P.M. (Time can be extended at the discretion of Election Commission)
