It is hereby notified for the information of all concerned that the **Sahiwal Women Chamber of Commerce and Industry (SWCCI)** has conducted its elections in accordance with the SWCCI Election Schedule for the year **2026–2028** and the Trade Organizations Rules, 2013.

As Per the Election Schedule approved by the SWCCI Executive Committee on 13th July 2026, nominations were invited for **10 Executive Committee seats** for the 2026–2028 term.
